The undersigned, being all members of the Board of Directors ("Board") of Generation: You Employed, Inc., a New York non-profit corporation ("Corporation"), authorize the adoption of the following resolutions by unanimous written consent in a meeting pursuant to Section 708 (b) of the New York State Nonprofit Corporation Law and Article III, Section 9 of the Seventh Amendment and Bylaws of the Corporation ("Bylaws"):

CONSIDERING that all the members of the Board of Directors have determined that it is in the interest of the Corporation to request the update of the Corporation's registry as a non-profit entity under the Special Tax Regime of Colombia ("RTE") with the Tax and Customs National Authority ("DIAN").

NOW, THEREFORE, BE IT RESOLVED that Catalina García Pradilla will be and is hereby authorized as the legal representative of the Corporation in Colombia to carry out the update to the registration before the DIAN for the RTE; and it has also:

DECIDED that Mona Mourshed, in her capacity as Chief Executive Officer (CEO) and Legal Representative of the Corporation, will be and is hereby authorized to make any certificate and representation on behalf of the Board as required by the process of updating the RTE registry before the DIAN, including without limitation the representations established in Annex A of this Agreement that have also been unanimously accepted by the Board of Directors of Generation: You Employed, Inc.


